In consideration of you entering into the contract on behalf of the Purchaser we (Name and Address of Customers Bank) (the "Demand Address"), hereby give you our guarantee and irrevocably and unconditionally undertake to pay you any amount or amounts not exceeding in total a maximum of (£ Amount in Numbers) on receipt of your first demand in writing addressed to us at the Demand Address (or to such other address that we may notify to you in writing to the Beneficiary Address (as defined above) to be the Demand Address), over original hand-written signature(s), accompanied by your signed statement certifying that the demand is in respect of an amount due to you but which the Purchaser has failed to pay. For the avoidance of doubt any document(s) received by way of facsimile or similar electronic means is/are not acceptable for any purposes under this guarantee. Any demands must bear the confirmation of your bankers that the signature(s) thereon are authentic.

This guarantee is valid for written demands received by us on or before (Date – Minimum Three Years) after which date our liability to you under this guarantee will cease and this guarantee will be of no further effect.

More than one demand may be made under this guarantee. Any payment to be made under this guarantee shall be made by us within five days after the date of receipt of the relevant demand, by payment to the account which you specify in such demand or, if no such account is specified in a demand, by sending a cheque made payable to you to the address shown at the beginning of this guarantee or to such other address as you may notify to us in writing to the Demand Address for such purpose (the "Beneficiary Address").

This guarantee is personal to you and is not assignable.

This guarantee shall be governed by English law.
